Semdex closed higher today gaining 4.48 points, closing the day at 1,833.49 which represents a gain of 0.24%. Sem-7 closed higher at 343.15 points. The total volume traded on the market amounted to 813,897 while the total value traded was Rs 110,500,215.60. The market P/E is 10.99 and the dividend yield is 3.11. Top gainers on the official market are UBP which closed at Rs 113.00, a gain of 0.89%, NRL which closed at Rs 23.20, a gain of 0.87% and GIDC which closed at Rs 23.30, a gain of 0.87%. Top losers on the official market are MDIT which closed at Rs 5.15, a loss of 2.83%, AIRM which closed at Rs 13.60, a loss of 1.45% and MOR which closed at Rs 26.40, a loss of 0.75%. On the official market, foreign purchases were Rs 102,308,131.60 and sales were Rs 26,720,145.00.
